I. Testing, Teaching and Learning...

#### Some exciting updates:

- Testing is underway!
- In response to recent reading assessment data, teachers in grades K-2, as well as Title I and Special Education are currently immersed in an off-site/on-site hybrid PD series with CSDE called READ CONN that is designed to improve our ability to meet the needs of our youngest readers
- On May 21st, we will celebrate the launch of year-long technology integration initiative with Capitol Region Educational Services and our Pre-K through 8 teachers. Besides beginning a transition to chromebooks (for all teachers) and Google docs, teachers will be trained in digital story telling and the applications SeeSaw and Nearpod which will enhance student engagement, support student portfolio compilations, and create rich student/teacher/parent digital sharing environments

# II. NAEYC: SBS PreK accreditation

Our site visit took place on Thursday, April 19. The daylong visit consisted of classroom observations and a comprehensive review of our classroom and program portfolios. The official decision for accreditation is due within the next 90 days. Stay tuned.

"The Connecticut State Department of Education (CSDE) has identified Side By Side Charter School as a school that is demonstrating good academic growth on the Smarter Balanced assessments.
